Excellence in comprehensive cancer care is underpinned by:

- 1. World class research and clinical trials
- 2. Comprehensive data collection, sharing and reporting
- 3. An engaged, capable and future-focused multidisciplinary cancer workforce that is well-equipped and well-supported to work at the top of their scope of practice

Improve access for all Australians to person-centred, research-driven, comprehensive cancer care, regardless of who they are or where they live

Drive uptake of the Optimal Care Pathways as the standard of care

Champion **a national comprehensive data ecosystem** across the cancer continuum, to promote nationally consistent data collection and reporting, drive optimal care and support better patient outcomes

Enable the **monitoring and reporting of system-based performance** to identify and support improvements in cancer control

Promote a culture of **collaboration**, **engagement**, **and knowledge sharing** across the cancer control sector

Provide strategic leadership to the sector by continuously building system capacity and capability

Australian Cancer Plan 2-year action 3.2.2

Develop a national framework for networked, distributed comprehensive cancer care, to facilitate provision of services as close as safely possible to where patients live. This will include the role of Comprehensive Cancer Centres to enhance patient outcomes, strengthen transparency and accountability, and drive continuous improvements for all patients across the network regardless of where the care is provided.

Australian Cancer Plan 5-year action 3.5.2

Establish an Australian Comprehensive Cancer Network (ACCN) to ensure connectivity and sharing of experience between Comprehensive Cancer Centres, other cancer services, regional hospitals, community and primary care. The establishment of an ACCN will increase equity of access across services for all patients, deliver cancer care close to home, and monitor evidence-based system performance.
